
#### Official Newsletter of the Three Rivers Bernese Mountain Dog Club

She was very good at hopping around through Christmas and New Year's. Recently, she was not her happy self and was slowing down. It was time. The pain with this cancer is bad. I can't believe she's not here to greet me with her wagging tail and smile. I am so amazed with these dogs. They are the best.

Welcome to the Club, Becki and Dave!








Randy and Gigi and their Berner (Quest - 8 months old) live in Beaver Falls, PA.


## Berners Diagnosed with Sub-Aortic Stenosis (SAS)

The BMDCA Health Committee Chair, Pat Long, has requested that the Regional BMD clubs ask if anyone is aware of Berners who have been diagnosed with Sub-aortic Stenosis (SAS). We would encourage you to respond to the referenced survey, if applicable.

\*\*\*

"Sub-aortic Stenosis (SAS) is a narrowing of the aortic valve of the heart. The milder versions may not negatively impact the dog, but the more severe cases can cause sudden death. It is hereditary in a number of breeds, and we do see it in Bernese.

Very few dogs are identified in Berner-Garde as having sub-aortic stenosis (SAS), which makes it difficult to justify large expenditures on research. The BMDCA is conducting an anonymous survey to gain information about how much of a problem the disease may be in our breed.



If you own or have owned a Berner with diagnosed or suspected SAS, we need to hear about it.

If you have produced – as the owner of a sire or dam – a Berner with diagnosed or suspected SAS, we need to hear about it.

Participating dogs may be living or have died. Please repeat the survey for each dog if you have multiple dogs with diagnosed or suspected SAS to report. They all matter.

The survey takes less than five minutes to complete and again; and it is anonymous.

## Splash'n Dash Hold Harmless Agreement - Must be Signed by all Attendees



This HOLD HARMLESS AGREEMENT (the "Agreement") is made as of the date signed below by and between Splash 'n Dash K9 Sports, Inc. (hereinafter "SND") and

(hereinafter "USER"). SND and USER are sometimes individually referred to as "Party" and collectively referred to as the "Parties."

WHEREAS, USER desires to use SND's property located at 1901 Sheena Drive, Plum, PA 15239 (the "Property") for personal dog training.

WHEREAS, in exchange for making the Property available to USER for such purposes, USER desires to hold harmless SND from any claims and/or litigation arising out of the USER's use of the Property. USER agrees to abide by any and all rules, guidelines and policies set by SND.

IN CONSIDERATION of the mutual covenants and conditions contained herein, SND and USER agree as follows:

- 1. Hold Harmless. Upon the use of the Property by USER or any of its agents, family members, guests or invitees for the purposes specified herein, the use of the Property shall be entirely at USER's own risk and USER assumes all risk and full responsibility for USER's own health, wellbeing and safety, USER shall defend, indemnify, and hold harmless SND from any and all actual or alleged claims, demands, causes of action, liability, loss, damage and/or injury and/or transmission of disease (to property or persons, including without limitation wrongful death), whether brought by an individual or other entity, or imposed by a court of law or by administrative action of any federal, state, or local governmental body or agency, arising out of or incident to any acts, omissions, negligence, willful misconduct or knowing exposure to others of COVID-19 or other illnesses or risk of illness by USER, its agents, family members, guests or invitees in connection with or arising out of USER's use of the Property. This indemnification applies to and includes, without limitation, the payment of all penalties, fines, judgments, awards, decrees, attorneys' fees, and related costs or expenses, and any reimbursements to SND for all legal expenses and costs incurred by it.
- Authority to Enter Agreement. Each Party warrants that the individuals who have signed this Agreement have the legal power, right, and authority to make this Agreement and bind each respective Party.
- 3 Amendment; Modification. No supplement, modification, or amendment of this Agreement shall be binding unless executed in writing and signed by both Parties.
- 4. Waiver. No waiver of any default shall constitute a waiver of any other default or breach, whether of the same or other covenant or condition. No waiver, benefit, privilege, or service voluntarily given or performed by a Party shall give the other Party any contractual right by custom, estoppel, or otherwise.
- 5. Attorneys' Fees and Costs. If any legal action or other proceeding is brought in connection with this Agreement, the successful or prevailing Party shall be entitled to recover reasonable attorneys' fees and other related costs, in addition to any other relief to which the Party is entitled.
- 6. Entire Agreement. This Agreement [and the accompanying Premises Use Agreement] contains the entire agreement between the Parties related to the matters specified herein, and supersedes any prior oral or written statements or agreements between the Parties related to such matters.

## PA Governor Updates Licensing Fees and Better Protection for Dogs

Did you remember to buy your dog license(s) yet for 2024? If not, it is time to do so. Any dogs older than 3 months old are required by PA law to have a current dog license. And I wanted to bring to your attention that Governor Shapiro enacted an updated Dog Law to protect Pennsylvania Dogs, Consumers and Communities. This law was encouraged by animal welfare advocates, kennel owners, country treasurers, and local law enforcement agencies.

As a part of this law, the licensing fee has increased. It is the first time in nearly 30 years that the price of an annual dog license has increased. As of February 1, 2024, the annual fee will be \$8.70 per dog. And the price is no longer impacted by whether your dog is spayed or neutered. If you choose to get a lifetime license for your dog, it will be \$52.70 per dog; however, your dog is must be tattooed or chipped. In addition, a Senior Citizen licensing rate is still available to seniors. Licenses can be obtained by contacting your County's Treasurer's office. In addition to the change in fees, fines for unlicensed dogs will range from \$100 - \$500. So, make sure your dog is licensed.

There are some positive updates regarding kennels and shelters in the updated law:

- Kennels and shelters that offer dogs for sale must include their kennel license number in advertisements
- Kennels selling or adopting dogs at retail to the public must disclose breeder information, vaccination and medical documentation, and any bite attacks on a human or domestic animal
- Dogs imported into PA kennels must be isolated for at least 14 days
- And several other changes to already declared "dangerous" dogs

As always, dogs are personal property, and owners are responsible for damages causes by their dog.


